1. Lake County FSC activities (25 min)
 - a. Funding/ Project Updates
 - i. Relaunch of LCFSC Defensible Space Program
 1. Thank you to Supervisor Pyska for committing 50k in funding towards an additional round of Defensible Space programming
 - ii. Mobile Tool Cache
 1. Still live! Any additional promotional support is greatly appreciated!

2. Partner reports (20 min)
 - a. CLERC
 - i. Awarded CAL FIRE Forest Health Grant - will support work on the North Shore and support further implementation and support planning for Lake County's first CalVTP analysis.
 - ii. Middletown Biochar project was huge success! Unfortunately, it seems unlikely at this time that PG&E will return to Lake County to continue this work at this time. Distributed 350 supersacks (1 cubic yard) to residents.
 - iii. Still not under contract for round 2 of CWDG. Expect to have additional information regarding round 3.
 - b. SSCRA
 - i. Hosted kickoff to CWPP on June 7th in Cobb. Event was well-received. Gave away 50 oak seedlings! Multiple presentations and sessions on how to develop and support a fire-adapted landscape. Also hosted sessions on how to build local capacity and how to support a local circular economy. Chief Duncan also gave his fire season preview.
 - ii. Already planning for another event! Distributing a poll to identify priority topics.
